**The Position** - The School Board of Amelia County Public Schools seeks an outstanding educational leader to serve as superintendent. The start date for the new superintendent will be on or before July 1, 2019. Amelia County Public Schools is an equal opportunity employer.

**The Division** - Amelia County ..... is located just west of Richmond in the Commonwealth of Virginia. The county is included in the Greater Richmond Region, and its county seat is Amelia Courthouse. Amelia County was created in 1735 from parts of Prince George and Brunswick counties, and it was named in honor of Princess Amelia of Great Britain. Parts of the county were later carved out to create Prince Edward and Nottoway counties. Amelia County's population is approximately 12,690.

Amelia County Public Schools serves over 1,750 students. ACPS .... is comprised of one elementary, one middle, one high school, a technical/career center, and an alternative education center and participates in two regional governor's schools. The division employs over 250 professional and operational staff.
